## PERSON SPECIFICATION

We are looking for a Junior Researcher in neurorehabilitation (degree in relevant field e.g. physiotherapist, MD), interested in carrying out clinical research activities and using innovative technologies applied to patients with neurological disorders. The successful candidate will collaborate with various research laboratories present within the institute; will participate in the enrolment of patients for research projects and contribute to database management. The successful candidate will contribute to the assessments and / or rehabilitation treatments, as well as will contribute to scientific dissemination through publications writing and presentations at conferences.

The terms, conditions, and starting date of the assignment, as well as the overall remuneration, will be set out in the individual contract.

## METHOD OF COMPLETION

The selection will be based on evaluation of the curriculum vitae of the candidates and an interview. The evaluation is aimed at identifying the candidate whose characteristics are as consistent and suitable as much as possible for the post to be covered.

# GENERAL REQUIREMENTS FOR PARTICIPATION

The successful candidate should have the following:

- a) Italian citizenship, or citizenship of one of the member states of the European Union, or belonging to a non-EU state in compliance with all the requirements for residence in Italy,
- b) lack of a criminal record and ongoing criminal proceedings,
- c) good physical fitness. The assessment of physical fitness will be carried out by the competent doctor of the San Camillo IRCCS Srl Società Unipersonale, before signing the contract.

# **Qualifications:**

- a) Master of Science degree or equivalent qualification
- b) At least 1 publication in a scientific journal
- c) Good knowledge of the English language

It is preferable to have a research doctorate in a field like the professional profile to which they belong. Candidates who meet this requirement will be given priority when creating the ranking list.

#### APPLICATION PROCESS

The application form must be submitted by completing and sending the attached form, accompanied by the curriculum vitae and a short presentation letter (max 10 lines), together with a copy of a valid identity document.

#### **DEADLINE AND SUBMISSION PROCESS**

The application to participate in the selection, drawn up on plain paper and signed, must be addressed to the Scientific Director of San Camillo IRCCS Hospital S.r.l. Società Unipersonale, and can be submitted by e-mail selezioni@ospedalesancamillo.net, by 16.08.2022. The application and all documentation must be attached in a single pdf file.

#### **INTERVIEW**

The interview (in English language) will be performed remotely via video call by using the GARR EduMeet platform on **05.09.2022**. The admitted candidates will receive the link to connect to the video call <u>30 minutes before the interview</u>. It will be sufficient to open the link via browser, without the need to install programs or make registrations. Please note that during the interview selected candidate must show a valid identity document. The list of candidates admitted to the selection and the schedule of the oral tests will be published on the website at least 5 days before the interview. No-show at the interview will be considered as resignation.

#### RESULT OF THE INTERVIEW

In relation to the curriculum vitae and result of the interview - subject to a justified evaluation - the Commission identifies, if possible, the suitable candidate whose characteristics in terms of competence and professional skills are the most compliant and suitable for the position to be covered.

The outcome of the procedure will be communicated to the candidates who have participated in the interview, as well as published on the Institute's website.

The completion of the employment relationship remains in any case subject to the assessment of the unconditional psycho-physical suitability for the profile, as well as the delivery of the documentation certifying the possession of the requirements.
